(“DreamWorks”), and sets out the intellectual property rights You grant to DreamWorks in the contributed materials. If you agree to be bound by these terms, fill in the information requested below and sign the CLA where indicated below. DreamWorks must have a CLA on file that has been signed by each Contributor, indicating agreement to the license terms below. This license is for your protection as a Contributor as well as the protection of DreamWorks and its users and does not change your rights to use your own Contributions for any other purpose. These terms and conditions constitute a binding legal agreement.

You accept and agree to the following terms and conditions for Your present and future Contributions submitted to DreamWorks. Except for the license granted herein to DreamWorks and recipients of software distributed by DreamWorks, You reserve all right, title, and interest in and to Your Contributions.

1. Definitions.

1.1. “You” (or “Your”) shall mean the copyright owner or legal entity authorized by the copyright owner that is making this Agreement with DreamWorks. For legal entities, the entity making a Contribution and all other entities that control, are controlled by, or are under common control with that entity are considered to be a single Contributor. For the purposes of this definition, “control” means (i) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (ii) ownership of fifty percent (50%) or more of the outstanding shares, or (iii) beneficial ownership of such entity.

1.2. “Contribution” shall mean the code, documentation or other original works of authorship expressly identified in Schedule B, as well as any original work of authorship, including any modifications or additions to an existing work that is intentionally submitted by You to DreamWorks for inclusion in, or documentation of, any of the products owned or managed by DreamWorks (the “Work”). For the purposes of this definition, “submitted” means any form of electronic, verbal, or written communication sent to DreamWorks or its representatives, including but not limited to communication on electronic mailing lists, source code control systems, and issue tracking systems that are managed by, or on behalf of, DreamWorks for the purpose of discussing and improving the Work, but excluding communication that is conspicuously marked or otherwise designated in writing by You as “Not a Contribution.”

2. **Grant of Copyright License.** Subject to the terms and conditions of this Agreement, You hereby grant to DreamWorks and to recipients of software distributed by DreamWorks a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable copyright license to reproduce, prepare derivative works of, publicly display, publicly perform, sublicense, and distribute Your Contributions and such derivative works.

3. **Grant of Patent License.** Subject to the terms and conditions of this Agreement, You hereby grant to DreamWorks and to recipients of software distributed by DreamWorks a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable patent license to make, have made, use, offer to sell, sell, import, and otherwise transfer the Work, where such license applies only to those patent claims licensable by You that are necessarily infringed by Your Contribution(s) alone or by combination of Your Contribution(s) with the Work to which such Contribution(s) was submitted.

4. Representations.

4.1. You represent that You are legally entitled to grant the above license. You represent further that each employee designated on Schedule A below (or in a subsequent written modification to that Schedule) is authorized to submit Contributions on Your behalf.

4.2. You represent that each of Your Contributions is Your original creation (see Section 5 for submissions on behalf of others).

4.3. You represent that the licenses you grant to DreamWorks under this CLA are pursuant to the Mozilla Public License Version 2.0.

4.4. You agree to notify DreamWorks when any change is required to the list of designated employees authorized to submit Contributions on Your behalf.

5. **Submission on Behalf of Others.** If You wish to submit work that is not Your original creation, You may submit it to DreamWorks separately from any Contribution, identifying the complete details of its source and of any license or other restriction (including, but not limited to, related patents, trademarks, and license agreements) of which You are personally aware, and conspicuously marking the work as "Submitted on behalf of a third-party: [NAME HERE]".

6. **Support.** You are not expected to provide support for Your Contributions, except to the extent You desire to provide support. You may provide support for free, for a fee, or not at all. Unless required by applicable law or agreed to in writing, You provide Your Contributions on an "AS IS" BASIS, WITHOUT WARRANTIES OR CONDITIONS OF ANY KIND, either express or implied, including, without limitation, any warranties or conditions of TITLE, NON-INFRINGEMENT, MERCHANTABILITY or FITNESS FOR A PARTICULAR PURPOSE.
